

1. Appointment shall be subject to work and conduct of the candidate in the college/Hospital/Dispensary remaining satisfactory during his/her tenure. In the case of misconduct or negligence in duties or found indulging in strike or any other such activities Which affect the hospital services/patient care, the tenure appointment of doctor shall be terminated without any notice.
2. The doctor shall be required to stay in the College/Hospital premise if residential accommodation is available and near college campus in case of non-availability of residential accommodation.
3. The candidate shall not indulge in any private practice during his/her tenure and if found doing so his/her tenure appointment shall be terminated forthwith.
4. Salary shall be disbursed only after satisfactory report from Inspector General of Police, CID, will be received.
5. Any appointee (Junior Resident) intending to leave shall have to provide one-month prior notice duly forwarded by the concerned HOD or else the Junior Resident shall have to deposit one month salary in the institution.
6. He/she will not participate in any kind of strike during the period of his/her tenure as the services are covered under ESMA.
