The following candidates who had applied for the posts of Senior Residents/Demonstrator/Tutor in various departments of Government Medical College & AH Udhampur notified vide advertisement Notice No:- 21 of 2023 dated 27-12-2023, as recommended by the selection Committee, sanction is hereby accorded to the engagement of the following Doctors as Registrars/Demonstrator in various discipline of Government Medical College, Udhampur on tenure basis initially for a period of 01 year (extendable upto 3 years) against the available vacancy.

The selections are made strictly as per eligibility criteria notified vide SO 673- JK (HME) of 2022 dated 19-09-2022, and selection criteria notified vide SO 282-JK (HME) of 2023 dated 04-04-2023.


The appointee shall be allowed to join only on production of the following documents/certificates in original:

1. Date of Birth Certificate
2. All Qualification Certificate.
3. Affidavit duly attested by First Class Magistrate.
4. Domicile Certificate, UT Of J&K.
5. Any other document as required U/Rules.

However, engagement of selected doctor shall be subject to following terms and conditions:

1. The doctors shall submit their joining report in the office of Principal GMC Udhampur within 07 days (**4PM sharp**) from date of issuance of this selection order.
2. That they shall submit an affidavit duly attested by first class magistrate to the effect that:

- a. He/She is non-PSC candidate and in case of PSC candidate he/she shall submit NOC from the competent authority and proper relieving from the parent department within a period of 15 days from the publication of this order, failing which he/she will not be able to join in this institution.
- b. He/she will complete his/her sanctioned tenure and will provide 01- month prior notice before resignation from the post.
3. First month's salary of the candidate shall remain in deposit with the accounts department as security and shall be paid on successful completion of the tenure appointment.
4. The Registrars/Demonstrator shall be asked to give and undertaking to the effect that he/she have read the aforesaid terms and conditions and shall abide by the same on an affidavit duly attested by Magistrate before he/she is allowed to join.
5. The appointee shall submit his /her joining report to the U/Signed only after a formal letter sent to the departments concerned after and ensuring that all the requisite formalities have been completed.
6. Salary will be disbursed only after the receipt of proper CID verification report of selected candidates.
7. The candidature will be cancelled at any stage of recruitment process or service tenure without any prior notice, if it is found that documents submitted by the selected candidates are not genuine or are forged.
8. No, experience certificate will be issued before completion of 02 years tenure.
9. Sanctioning of any kind of leave shall be strictly as per the provision of SO-364 of 2020.
10. The waitlist shall be operationalised if any selected candidate fails to join on last date of joining time and the candidates shall be informed accordingly.
11. **This order is without any prejudice to any writ petition lying pending before any Hon'able Court of Law.**
