The appointment is strictly based on their merit for a period of one year extendable up to maximum of 06 years (one year at a time and subject to good work and conduct) or till the selection /promotion is made in accordance with rules of recruitment governing their posts, whichever is earlier.

NOTE:-The selected candidates/Candidate are directed to report to the Principal, Government Medical College, Udhampur **within period of 07 days/by or before 08/08/2024 by 4:00pm** from the date of issuance of this order and in case of failure of selectee to join within the stipulated period of time, his/her selection shall be deemed to have been cancelled ab-initio without further notice.

The selected candidate shall be allowed to join only on the production of following certificates/testimonials in originals:

1. Academic /Technical Qualification.
2. Date of Birth Certificate.
3. Health Certificate from the concerned CMO of the District.
4. Domicile Certificate.
5. Character certificate duly issued by the concerned police station.

The selection is strictly governed by the following terms and condition of So-364

1. The selection under these rules shall not entitle the selected candidate/candidates to any preferential claim for regular appointment under normal process of selection/appointment.
2. The selection on Academic arrangement basis shall by itself stand terminated on the attainment of 65 years of age by the selected candidates.

3. The Service of their candidature shall be terminated before the expiry of the tenure of appointment with one Month notice from either side of payment of one Month's salary in lieu of notice by appointing authority.

4. The selected candidates shall have to execute an agreement with the Government on the prescribed form appended as form "A" to So-364 of 2020.

5. The matter of discipline and conduct, of selected candidates shall be governed by the rules, regular and orders in vogue in the Civil Services Rules on the subject.

6. Any residual matter shall be governed by SO-364 Dated: 27/11/2020.

7. The Salary of selected candidates shall not be drawn and disbursed unless satisfactory report of his/her concerned documents/relevant document is received in his/her favour.

The selected candidate shall give an undertaking duly attested by the Ist Class Magistrate in shape of affidavit to the effect that:

(a) If the verification from the concerned issuing authorities, the qualification certificates is found forged, false or failure, the selectee shall have no claim for selection.


(b) The selected candidates shall abide by all term and conditions as laid down in selection order.

(c) The selected candidates shall have to execute an agreement state that he/she will not part in any kind of political activities /strikes.
