**Subject: Final Selection List and Appointment Order for Junior Staff Nurse and Lab. Technician on Academic Arrangement Basis.**

Whereas, the Government Medical College, Udhampur, advertised 05 posts of Lab. Technician and 30 posts of Junior Staff Nurse vide advertisement notice no:-08 of 2023 dated 04-05-2023 read with Addendum Vide No. GMC/UDH/2023-24/143 dated 09.05.2023; and

Whereas, an MCQ-based written test was conducted for these posts on 18.08.2024; and based on the marks obtained in the written test and the implementation of relevant reservation rules, a Provisional Selection List and Waiting List were issued vide Order No:18 of GMCU, 2025, dated 31.07.2025 seeking objections from the candidates within a period of 14 days from the issuance of the list; and

Whereas, pursuant to the above, several representations/objections were received by the office and all of them had been redressed; and

Now, therefore, after considering and redressing all the representations / objections sanction is hereby accorded to the final selection and appointment of the candidates as Junior Staff Nurses and Lab. Technicians enclosed as **Annexure A** (Selection Lists) and **Annexure B** (Waiting Lists) on an Academic Arrangement basis, initially for one year subject to the following terms and conditions.

**Terms and Conditions of Appointment**

The appointment of the above candidates is subject to the following conditions:

1. The selected candidates are directed to join in the office of the Principal, Government Medical College, Udhampur, within 7 days from the date of this

order. Failure to report within the stipulated period shall result in the cancellation of their selection without further notice.

2. The appointees must bring all academic, technical, domicile, category, and character certificates along with their Date of Birth Certificate at the time of joining. Any discrepancy found in the documents will lead to the rejection of their candidature.

3. The candidate shall submit an affidavit duly attested by a first-class magistrate, affirming that they are not involved in any criminal activity, will not leave before the completion of one year, and will not participate in any strikes or misconduct.


4. Salary will be disbursed only after a proper CID verification of the candidates is completed.

5. The engagement is on an academic arrangement basis for an initial period of one year, which may be extended up to a maximum of six years, subject to good performance and conduct. This arrangement does not confer any right to a regular appointment.

6. Any misconduct shall make the appointee liable for termination without prior notice. No experience certificate shall be issued if the individual leaves or fails to serve for at least six months.

7. The selection is completely provisional and is not subject to the outcome of any writ petition before any court.

Note – The candidates who have already submitted their documents need not to submit again.




