- (a) He /She is non-PSC candidate and in case of PSC Candidate he/she shall submit NOC from the competent authority and proper relieving from the parent department within a period of 15 days from the publication of this order, failing which he/she will not be able to join in this institution.
- (b) He/she will complete his/her sanctioned tenure and will provide 01- month prior notice before resignation from the post.
- **3.** First month's salary of the candidate shall remain in deposit with the accounts department as security and shall be paid on successful completion of the tenure appointment.
- 4. The Senior Residents/Demonstrator shall be asked to give an undertaking to the effect that he/she has read the aforesaid terms and conditions and shall abide by the same on an affidavit duly attested by first Class Magistrate before he/she is allowed to join.
