The appointee shall be allowed to join only on production of the following documents/certificates in original:

1. Date of Birth Certificate
2. All Qualification Certificates
3. Affidavit duly attested by 1st Class Magistrate
4. Domicile Certificate, UT of J&K
5. Any other document as required under rules

**Terms and Conditions**

1. Doctors shall submit their joining report in the office of Principal GMC, Udhampur within 07 days (4 PM sharp) from date of issuance of this selection order.
2. They shall submit an affidavit duly attested by First Class Magistrate to the effect that:
  - He/she is non-PSC candidate. In case of PSC candidate, NOC from competent authority and proper relieving from parent department must be submitted within 15 days.
  - He/she will complete sanctioned tenure and provide 01-month prior notice before resignation.
3. First month's salary shall remain deposited with accounts department as security, payable only on successful completion of tenure.

4. Senior Residents/Demonstrators shall give an undertaking on affidavit that they have read and will abide by the terms and conditions.
5. Joining report shall be submitted only after formal letter sent to concerned departments ensuring all formalities are complete.
6. Salary will be disbursed only after receipt of proper CID verification report.
7. Candidature will be cancelled at any stage if documents are found forged or not genuine.
8. No experience certificate will be issued before completion of 02 years tenure.
9. Leave sanctioning shall be strictly as per Government Order No. 451-JK (HME) of 2024 dated 08.07.2024.
10. This order is without prejudice to any writ petition pending before any Hon'ble Court of law.
