- ...Within five days of receiving the complaint, the complainant can submit details of witness with their contact details etc.
- ...The complainants and respondents are intimated at least 72hours in writing for a meeting with the ICC members.
- ...All proceedings are recorded in writing and endorsed by the persons concerned.
- ...A Report is prepared within ten days of conclusion of an enquiry and submitted to the Principal GMC, Udhampur.
