**Sub: Operationalization of waiting list of Junior Residents in various disciplines of Government Medical College Udhampur on academic arrangement basis as per SO-364 dated: 27.11.2020.**

**Ref. Order No. 31 GMCU of 2025 dated 30.12.2025 issued by endorsement No. GMC/Estt/Udh/2025-26/2577-83 dated 30.12.2025**

Whereas, the Government Medical College, Udhampur advertised 25 posts of Junior Residents Vide Advertisement Notice No. 08 of 2025 dated 07.10.2025 issued under endorsement No. GMC/Estt./Udh/2025-26/2371-78 dated 07.10.2025. on tenure basis for a period of 06 months (extendable up to 01 year subject to the good conduct and performance of the candidates) against the available vacancies.

Whereas, an MCQ-based written test was conducted for the posts on 25.10.2025 and based on the marks obtained in the written test 25 candidates were selected for engagement as Junior Residence in various disciplines at GMC Udhampur and the award Roll of all the doctors were attached in the provisional selection list of Junior Residents.

Whereas among 25 Junior Residents selected for the post of Junior Residents, only 18 Junior Residents joined the institution within the stipulated period while 07 junior Residents failed to join thus leading to cancellation of their selection vide Order No. 29-GMCU of 2025 dated 15.12.2025 issued by endorsement No. GMC/Estt/Udh/2025-26/2581-85 dated 15.12.2025.

Whereas vide Order No. 30 GMCU of 2025 dated 17.12.2025, t, the next waiting list was operated and next 07 Junior Residents have been directed to submit their joining report within 07 days. But out of 07 Junior Residents, only 04 joined the institution while 03 failed to join within the prescribed time period thus leading to cancellation of their selection vide Order No. 31 GMCU of 2025 dated 30.12.2025.

Now, therefore, accordance with SO-364 dated 27.11.2020 and to fill up Vacant posts as per the terms and conditions of the advertisement, the final waiting list of Junior Residents is hereby operationalized enclosed as **Annexure 'A'**.

**The appointee shall be allowed to join only on production of the following documents/Certificates in original.**

1. Date of Birth Certificate.
2. All Qualification Certificate (MBBS Degree, All Profs. Marks sheets, Attempt Certificate, JKMCIR Registration certificate, ICC, PG/MD/MS if any).
3. Affidavit duly attested by 1<sup>ST</sup> Class Magistrate.
4. Domicile Certificate, UT of J&K.
5. Any other document as required under rules.

**However, engagement of the selected doctor shall be subject to following terms and conditions:**

1. The doctors shall submit their joining report in the office of Principal GMC, Udhampur within **07 days (4PM Sharp)** from date of issuance of this selection order.
2. That they shall submit an affidavit duly attested by First Class Magistrate to the effect that he/she will complete his/her sanctioned tenure and will provide 01- month prior notice before resignation from the post. First month's salary of the candidate shall remain in deposit with the accounts department as security and shall be paid on successful completion of the tenure appointment.
3. The Junior Residents shall be asked to give an undertaking to the effect that he/she has read the aforesaid terms and conditions and shall abide by the same on an affidavit duly attested by first Class Magistrate before he/she is allowed to join.
4. Salary will be disbursed only after receipt of proper CID verification report of selected candidates.
5. The candidature will be cancelled at any stage of recruitment process or service tenure without any prior notice, if it is found that documents submitted by the selected candidates are not genuine or are forged.
6. No experience certificate will be issued before completion of 06 months tenure.
7. Junior Residents will be whole time and non-practicing. During their tenure of six months, the Junior Residents shall not be entitled to any kind of leave except the CASUAL LEAVE for 7 1/2 days only. Junior Residents availing excess leave during the period of resident ship shall have to repeat the same in his/her own without remuneration stipend after obtaining proper order from office of the Principal, Government Medical College, Udhampur.
8. During their tenure as Junior Residents, their services shall be governed under the Rules of Conduct and Discipline, as applicable on other doctors who are member of the regular establishment.
9. The services of the Junior Residents shall be terminated by the Principal, Govt. Medical College, Udhampur, without any prior notice if they indulge in strike or any other activity which is against the interest of institution or when their work and conduct is reported to be unsatisfactory by the Head of Department/Unit or any officer, with whom they are attached. The Junior Residents thus terminated will have to refund stipend in one instalment, if already received by them.

10. The Junior Residents shall have to remain in the College/Hospital premises for 24 hours and will be available for duty at any time during the day or night. They will leave the College / Hospital premises only after obtaining the permission from the concerned Authority and shall mark their attendance on ABBAS at the time of departure and arrival in the Hospital.
11. The Department of the Junior Residents can be changed after a period of three months depending upon the requirement and smooth functioning of the institution.
12. The Junior Residents will not be allowed to join Junior Resident ship in any other Institute before they complete the tenure in GMC Udhampur.
13. The Junior Residents will have to refund the stipend received by them in one instalment in case they leave before completion of their tenure.
14. This order is without any prejudice to any writ petition lying pending before any Hon'ble Court of law.
