Whereas, the Government Medical College, Udhampur advertised 25 posts of Junior Residents Vide Advertisement Notice No. 08 of 2025 dated 07.10.2025 issued under endorsement No. GMC/Estt./Udh/2025-26/2371-78 dated 07.10.2025.

Whereas, an MCQ-based written test was conducted for the posts on 25.10.2025 and based on the marks obtained in the written test, 25 candidates were selected for the post of Junior Residents in various disciplines at Government Medical College, Udhampur.

Whereas vide order No. 24 GMCU of 2025 dated 15.11.2025, 25 Junior Residents were engaged and directed to submit their joining report within 07 days (i.e 24.11.2025).

Whereas 18 Junior Residents joined the institution within the stipulated period of joining while 07 junior Residents failed to join the institution within the prescribed time.

Whereas vide order no. 29 GMCU of 2025 dated 15.12.2025, the candidature of 07 Junior Residents who failed to join within the stipulated time period was cancelled

Whereas vide order no. 30 GMCU of 2025 dated 17.12.2025, the next waiting list was operated and next 07 Junior Residents have been directed to submit their joining report within 07 days.

Whereas out of 07 waiting Junior Residents, only 04 Junior Residents joined the institution within the stipulated period of joining while 03 junior Residents failed to join the institution within the prescribed time.

Whereas in accordance to the terms and conditions of the advertisement **"in case of failure of any candidate to join within the stipulated time period, the next candidate in merit shall be invited to join"**

Hence, the candidature of the following candidates who failed to join stands cancelled ab initio
