**Sub: Cancellation of selection of Junior Residents in various disciplines of Government Medical College Udhampur on academic arrangement basis as per SO-364 dated: 27.11.2020.**

**Whereas**, the Government Medical College, Udhampur advertised 25 posts of Junior Residents in various disciplines vide Advertisement Notice No. 08 of 2025 dated 07.10.2025 issued under endorsement No. GMC/Estt. /Udh/2025-26/2371-78 dated 07.10.2025.

**Whereas**, an MCQ-based written test was conducted for the posts on 25.10.2025 and based on the marks obtained in the written test, 25 candidates were selected for engagement as Junior Residents in various disciplines at Government Medical College, Udhampur.

**Whereas** vide order No. 24 GMCU of 2025 dated 15.11.2025, 25 selected Junior Residents offered engagement as JR's and were directed to submit their joining within 07 days of the issuance of the said order.

**Whereas only** 18 Junior Residents joined the institution within the stipulated joining period and 07 junior Residents failed to join within the prescribed time.

Whereas in accordance to the terms and conditions of the advertisement "it is clearly mentioned that, in case of failure of any candidate to join within the stipulated time period, aforesaid the next candidate in merit shall be invited to join"

Now, therefore, in view of the above and in pursuance of So-364 of 2020 dated 27.11.2020 the engagement of the following selected candidates stands cancelled ab initio, as they failed to join within the prescribed stipulated period.
