The appointee shall be allowed to join only on production of the following documents/ certificate in original: -

1. Date of Birth Certificate.
2. All Qualification Certificate.
3. Affidavit duly attested by 1st class Magistrate.
4. Domicile Certificate UT of J&K
- 5 Any other documents as required under rule.

The engagement of the above-mentioned Registrars/Demonstrator shall, however, be subject to the following terms and conditions: -

1. Tenure appointment shall be subject to work and conduct of the Registrar/Demonstrator in the College/Hospital/Dispensary remaining satisfactory during his/her tenure. In the case of misconduct or negligence in duties or found indulging in strike or any other activities which affect the hospital services/patient care, the tenure appointment of doctors shall be terminated without any notice. In the event of any vacancy ceasing to exist in any discipline the last Doctors appointed in the discipline will be reverted to his /her parent service.
2. The Doctor shall be whole timer and shall not engage him/herself in private practice in case of PSC candidates. In lieu of the loss of practice he/she shall be entitled to non-practice allowance as admissible under rules. In the event of those doctors found resorting to private practice their tenure appointment will be terminated without any notice and disciplinary action will be taken against them.

3. The Doctor shall be required to stay in the College /Hospital premises if residential accommodation is available.
4. The Doctor shall be liable to be transferred from the College even during the period of Registrar-ship/ Demonstrator Ship his/her services is required elsewhere in the public interest.
5. No Registrar/Demonstrator appointed under this order shall be allowed applied for any job during the tenure of Registrar-ship/ Demonstrator-ship nor the controlling authority shall forward any such application to the concerned quarter if any forwarded by their parent department after taking up job of the Registrar/Demonstrator shall be treated as cancelled.
6. The Registrar/Demonstrator shall be asked to give and undertaking to the effect that he/she have read the aforesaid terms and conditions and shall abide by the same on an affidavit duly attested by the Magistrate before he/she is allowed to join.
7. The appointee shall submit his/her joining report to the undersigned only after a formal letter shall is sent to the department concerned after ensuing that all the requisite formalities have been completed.
8. Any appointee (Doctor) intending to leave the job shall have to provide one-month prior notice duly forwarded by the concerned HoD or else the doctor shall have to deposited one month's salary in this institution.
9. The candidates who fail to join within a period of 21 days (PSC) and (Non-PSC) 07 days from the date of issuance of the appointment order shall forego their right to appointment which shall be deemed to have been cancelled abinitio without any further notice.
10. The tenure shall be terminated at any time if the work and conduct is found unsatisfactory or in case of indiscipline / misconduct.
11. The appointee shall be authorised to take leave as per S.O. 364. Absence of more than one month from duties shall lead to cancellation of appointment without any prior notice.
12. No experience certificate will be issued before completion of two-year tenure.
13. **This order without any prejudice to any writ petitions lying pending before any Hon'ble Court of law.**
