Medical College, Udhampur purely on Academic Arrangement basis under S.O. 364 dated: 27.11.2020 initially for a period of one (01) year extendable up to maximum of 03 years subject to good conduct and satisfactory performance of the candidates.

Interested candidates can apply on prescribed application form annexed (Annexure-I) with this notification and submit the same to the office of undersigned by or before 06.05.2026 (4:00 pm sharp)

The application forms should be complete in all aspects and accompanied with a non-refundable bank draft of Rupees Five Hundred only from JK Bank in favour of Principal, Govt. Medical College, Udhampur. Incomplete application or those lacking the requisite fee will be summarily rejected.

The application form along with requisite documents (self-attested) should reach in the office of undersigned by registered post or by hand on or before 06.05.2026 **(4:00 pm sharp)**. Applications sent by any other mode or after the last date shall not be entertained.

Maximum age for eligibility to apply shall be 50 years as on cut-off date. The last date for the receipt of applications provided in the notification shall be the cutoff date for determining the eligibility.

APPLICATIONS SHOULD BE ACCOMPANIED WITH SELF ATTESTED COPIES OF THE FOLLOWING DOCUMENTS:

- 1.Date of Birth Certificate (10th Diploma/Mark sheet, any other).
- 2.MBBS/Diploma/MD/MS/DNB/Mch/DM all terms mark sheets and qualification of the respective specialty.
- 3.Attempt certificate of 1st,2nd, Pre-final and Final MBBS issued by concerned Universities.
- 4.MBBS degree and MCI/NMC/State Medical Council registration certificate.
- 5.Internship completion certificate.
- 6.Distinction / National scholarship / Honours / Medals / Academic Merit Certificate if any.
- 7.House-job (Jr.) certificate issued by concerned Principal or Equivalent authority.
- 8.FMGE certificate in case of MBBS & degree from outside the country.
- 9.Professional publications in a standard medical Journal if any.

SELECTION AND ELIGIBILITY CRITERIA:

The Selection & Eligibility Criteria is in terms of **Govt. Order No. 382-JK(HME) of 2024 & Govt. Order No. 383-JK(HME) of 2024 dated 20.06.2024**. In case of written test as decided by the Selection Committee the question paper will comprise of 50 questions (MCQ Based) of 100 marks (2 marks each) and there will be negative marking of **1/4(0.5)** marks per question.

TERMS AND CONDITION:

1. The candidates shall be paid salaries in accordance with S.O. 364 of 2020 Dated: 27-11-2020.
2. The maximum tenure of Senior Resident shall be (03) three years and no further extension shall be granted under any circumstances as mentioned in **Govt. Order No. 383-JK(HME) of 2024 dated 20.06.2024.**
3. Candidates may note that their candidature will remain provisional till the genuineness of their documents relating to educational qualification and professional qualification is verified by the Appointing Authority. The candidates are advised to go through the requirements of educational qualification and professional qualifications and certificates to satisfy themselves that they are eligible for the post. If the documents submitted by the candidates are found not substantiated or incorrect by the committee at any point of time, the candidature will be cancelled and appropriate legal action may be initiated.
4. The appointee shall be required to submit an affidavit duly attested by the Judicial Magistrate at the time of joining to the effect that he/she is not working in any other medical college and all the information in the application forms are true and correct and he/she will not leave the residency mid-way and will serve for the tenure period.
5. The candidates who have already completed their tenure as Registrar/Demonstrator/ Senior Resident/Tutor in any discipline need not to apply and their application forms shall not be considered. A separate application form is to be filled up for each post /specialty and fee is to be deposited separately for each post applied by the candidate.
6. Candidates are advised not to provide any false information or suppress any material facts. When submitting a hard copy of the application after being shortlisted, they are warned not to alter or tamper with any entry in any document or its attested/certified copy. They should not submit any tampered or fabricated documents. If there is any inaccuracy or discrepancy between two or more such documents or their attested/certified copies, an explanation regarding the discrepancy should be provided.

7. Candidates are subject to strict disciplinary standards. Any candidate found engaging in the following actions shall be liable to criminal prosecution and /or permanent or temporary debarment from examination by the selection committee:
- Obtaining wrongful support for their candidature.
 - Impersonating or procuring impersonation.
 - Submitting fabricated or tempered documents.
 - Providing incorrect or false information, or suppressing material facts.
 - Resorting to un fair means during the examination process.
 - Using irrelevant or obscene content in submission.
 - Misbehaviour in the examination hall or harassing or causing bodily harm to staff employed there.
 - Attempting to commit or abetting any of the afore-mentioned facts
8. The appointment of the candidate shall be terminable on either side by serving a prior notice of one month or on payment of one month's salary by the appointing authority. In case of a tie in merit secured by two or more candidates in the written test, the candidates who has scored more marks in MBBS shall be given preference. In case, the marks are also same, candidate older in age shall be preferred.
9. Along with the select list, a waiting list shall be maintained, which be valid for a period of 03 months, for each discipline. In case of failure of any candidate to join, the next candidate in merit shall be invited to join. In case a Senior Resident/Tutor leaves the tenured position within 03 months after joining, the Principal, Govt. Medical College Udhampur shall appoint a candidate next in merit in the last valid select list. No. Selected candidate who has joined the institution on a tenured position shall be given Experience certificate if he/ She fails to serve on the tenured position for at least 1 year.
10. The appointments against the advertised posts for non-PSC candidates shall always be on tenure basis without conferment of any preferential right on the engages for regular appointment against the post, which shall be made strictly in accordance with relevant recruitment rules.

11. The engaged doctors shall not be entitled to Private Practice or undertake simultaneous Part time/Full time Job anywhere else and he/she shall work in the institution on full time basis.

12. The vacancies are advertised as per the posts which are vacant or likely to fall vacant. However, the department may withdraw/alter number of vacancies or decides not to fill the vacancies at any point of time till the completion of selection process without any further notification.

This is without prejudice to any writ petition pending before any Hon'ble Court.
