Medical College Udhampur Hostel purpose of GMC students purely on temporary basis initially for a period of six months on monthly rent basis, may be extended to one year on same terms and conditions.

- 6. Building should accommodate maximum of 2-3 students in each room and if possible attached washroom should be there in building.
- 7. Building should have big common hall for student mess and space for running the kitchen of the students of around 20 x 20 sq. ft.
