ORDER

Whereas, Government Medical College (GMC) Udhampur invited applications for the engagement of Junior Residents vide the advertisement cited under reference (1), which explicitly stipulated that a candidate must not have served in any Government Department post-internship until the date of application;

Whereas, following the publication of the provisional merit list, formal grievances were received challenging the eligibility of certain selected candidates on the grounds of prior or ongoing government service:

Whereas, a Committee was constituted to verify these claims and ensure strict adherence to the terms and conditions of the advertisement;


Now, **therefore,** upon detailed verification of service records and after considering formal institutional clarifications, the following is hereby ordered:

1.Rejection of candidature: The candidature of the following Candidates is hereby **cancelled and withdrawn** ab initio, as they were found to have served in Government Departments, thereby violating the mandatory eligibility criteria:

GMC/UDH/2026-27/279 dated 30-04-2026 that her prior service as a Medical Officer at SMVDNSH was within a private/PPP-mode entity. As this does not constitute service in a "Government Department," her selection is found to be valid and in accordance with the prescribed criteria.
