Whereas application were invited from eligible candidates for the post of Technical Lab. Assistant on academic arrangement under SO-364 dated: 27/11/2020 in GMC and Associated Hospital Udhampur, UT of J&K vide advertisement notice No: 08 of 2023 Dated: 04.05.2023.

Whereas criteria as mentioned in the advertisement notice has been adopted for the preparation of selection list/ merit.

Now, in view of above and as recommended by evaluation cum screening committee in terms of SO-364 of 2020 dated 27/11/2020, the candidates as Annexure A(list enclosed), are hereby appointed as Technical Lab. Assistant against the available posts lying vacant in GMC and Associated Hospital Udhampur. The appointment is strictly based on their merit for a period of one year extendable up to maximum of 06 years (one year at a time and subject to good work and conduct) or till the selection /promotion is made in accordance with rules of recruitment governing their posts, whichever is earlier.

The appointed candidates/Candidate are directed to report to the Principal, Government Medical College, Udhampur **within period of 08 days/by or before 07/07/2024 by 4:00pm** from the date of issuance of this order and in case of **failure of appointee to join** within the stipulated period of time, his/her appointment shall deemed to have been cancelled ab-initio without further notice.

The appointed candidate shall be allowed to join only on the production of following certificates/testimonials in originals:

1. Academic /Technical Qualification.
2. Date of Birth Certificate.
3. Health Certificate from the concerned CMO of the District.
4. Domicile Certificate.
5. Character certificate duly issued by the concerned police station.
6. The salary of the appointee shall not be drawn and disbursed unless satisfactorily report of his/her concerned documents/relevant document is received in his/her favour.

The appointment is strictly governed by the following terms and condition of So-364

1. The appointment under these rules shall not entitle the appointed candidate/candidates to any preferential claim for regular appointment under normal process of selection/appointment.
2. The appointment on Academic arrangement basis shall by itself stand terminated on the attainment of 65 years of age by the selected candidates.
3. The Service of their candidature shall be terminate before the expiry of the tenure of appointment with one Months notice from either side of payment of one Month's salary in lien of notice by appointing authority.
4. The appointed candidates shall have to execute an agreement with the Government on the prescribed form appended as form "A" to So-364 of 2020.
5. The matter of discipline and conduct ,the appointment candidates shall be governed by the rules, regular and orders in vogue in the Civil Services Rules on the subject.
6. Any residual matter shall be governed by SO-364 Dated: 27/11/2020.
7. The Salary of appointee shall not be drawn and disbursed unless satisfactorily report of his/her concerned documents/relevant document is received in his/her favour.

The appointees shall given an undetaking duly attested by the Ist Class Magistrate in shape of affidavit to the effect that:

- (a) If the verification from the concerned issuing authorities, the qualification certificates is found forged, false or failure, the appointee shall have no claim for appointment.
- (b) The appointee shall abide by all term and conditions as laid down in appointment order.
- (c) The appointment candidates shall have to execute an agreement states that he/she will not part in any kind of political activities /strikes.

The order is issued subject to the outcome of any writ petitions pending in any court of law of the competent jurisdiction and any objection in this regards and receipt of satisfactorily verification viz-a-viz diploma /degree from respective/institution/university and other documents.
